**Equal Opportunity-** Membership to the Maverick Krewe (the "Krewe") shall be open to anyone regardless of race, creed, color or sexual orientation.

**Membership Description** – Membership in the Krewe is granted for a period of one year or less. The membership period begins upon receipt and acceptance of annual dues in the amount specified herein and ends on the last day of the Krewe's budget year, June 30, provided that Membership is not terminated earlier as provided in the Krewe's Membership Guidelines.

**Membership Requirements** -- Membership in the Krewe shall be by invitation only. No application shall be accepted from an active member of another Krewe. All prospective members must be sponsored by a member in "Good Standing" of the Krewe. Current members may sponsor their own application for the subsequent year but no guarantee is made that membership will be granted in the subsequent year. This completed and signed application, accompanied by a check made payable to "Maverick Krewe, LLC" in the amount of \$50.00 (the "Application Fee"), must be delivered to the address above for processing and overall approval by the Board. **Current members and members from the immediately prior year are not required to submit the \$50 application fee.** All new members must prove to be at least 21 years of age. Applications will not be considered without a check for the application fee or, in the case of current members and members from the immediately prior year, a check in the amount of \$100 as a deposit. A candidate denied membership will not be eligible to reapply for membership for one year following the date the application was acted upon. The application fee will be refunded to any candidate whose application is not accepted for Membership. **There will be NO REFUNDS of the application fee once Membership is offered.**

**Membership Dues** – Annual dues for membership to the Krewe will be \$250 per member, plus a one-time application fee of \$50.00 per prospective member. Costs for costumes and beads are the responsibility of the member. **There will be NO REFUNDS of the annual dues once paid.**

**Significant Other Dues** - Member's spouses, partners and adult children are encouraged to become members. The dues & fees are the same for all members.

## Indemnification Rider

In consideration of the opportunity of membership in the Maverick Krewe (the "Krewe"), \_\_\_\_\_ (the "Applicant"), agrees to indemnify and hold harmless the Krewe, its affiliates, its members, its vendors and each of their respective affiliates, directors, officers, agents, advisors, consultants, employees and controlling persons (the Krewe and each such other person or entity are hereinafter referred to as an "Indemnified Person"), from and against any losses, claims, damages, expenses and liabilities or actions in respect thereof (collectively, "Losses"), as they may be incurred, including all legal fees and other expenses incurred in connection with investigating, preparing, defending, paying, settling or compromising any Losses, whether or not in connection with any pending or threatened litigation in which any Indemnified Person is a named party) to which any of them may become subject (including in any settlement effected with the Applicant's consent, which shall not be unreasonably withheld) and which are related to or arise out of any act, omission, or event. The Applicant will not, however, be responsible under the foregoing provisions with respect to any Losses to the extent that a court of competent jurisdiction shall have determined by a final judgment that such Losses resulted from an Indemnified Person's gross negligence or bad faith.

The Applicant agrees that, except as provided in this Indemnification Rider, no Indemnified Person shall have any liability to the Applicant or its affiliates, including family members, directly or indirectly, related to or arising out of membership in the Krewe, except Losses incurred by the Applicant that a court of competent jurisdiction shall have determined by a final judgment to have resulted from such Indemnified Person's gross negligence or bad faith. In no event, regardless of the legal theory advanced, shall any Indemnified Person be liable for any consequential, indirect, incidental or special damages of any nature.

The obligations of the Applicant referred to above shall be in addition to any rights that any Indemnified Person may otherwise have and shall be binding upon and inure to the benefit of any successors, assigns, heirs and personal representatives of any Indemnified Person and the Applicant. The provisions set forth in this Indemnification Rider shall remain operative and in full effect regardless of any termination or denial of the Applicant's membership in the Krewe, and be governed by and construed in accordance with the internal laws of the State of Florida without regard to principles of conflicts of law.
